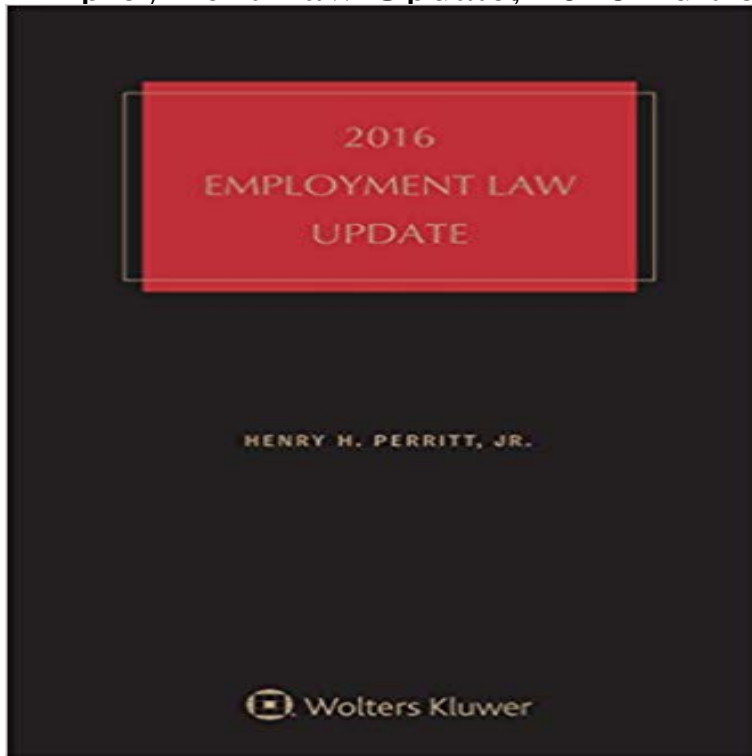


Employment Law Update, 2016 Edition
