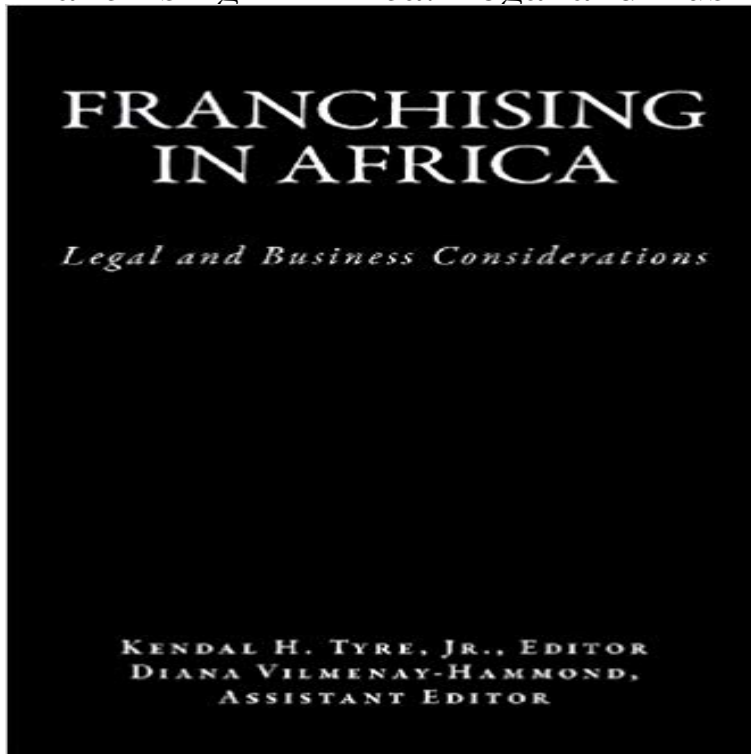


Franchising in Africa: Legal and Business Considerations
